## Do you have special medical needs?

**MEMBERS WHO** have a health problem requiring the use of special, electric-powered medical equipment should contact Horry Electric ASAP. Many need to obtain a Special Medical Needs Account Member Certification form.

Residential members with such conditions will be required to secure the signature of a licensed health care provider on the form and then return it to the co-op. The certification is valid for 91 days from the date of the signature of the health care provider. It is the member's responsibility to renew certification by obtaining the appropriate signatures on a new certification form and submitting it to the co-op. Details: (843) 369-2211.

# You Gotta Regatta!

Thanksgiving weekend tradition continues

**IF YOU'RE GOING** to be in Horry County over the Thanksgiving holiday, then You Gotta Regatta!

The Intracoastal Christmas Regatta, which always takes place on the Saturday after Thanksgiving, is a North Myrtle Beach/Little River tradition. It's organized by Yachts for Tots, which is active throughout the year. This is the 34th year for the event, which is scheduled for Saturday, November 24.

Yachts for Tots started out with three organizers in 1985. The crew now includes a core group of local volunteers who have a genuine interest in helping bring the boating community together to make a difference in the lives of children in Horry County. Penelope Hinson, our manager of PR, Marketing and Energy Management, has served on the committee since 1999.

"Being a part of this crew has been a great experience for me," says Hinson. "The Intracoastal Christmas Regatta is our flagship event, but the work of the Yachts for Tots crew goes on throughout the year."

Through fundraising activities and toy drives, the Yachts for Tots volunteers strive to meet the needs of children in Horry County who, for one reason or another, might be falling through the cracks of traditional agencies.

Committee members rely on the counselors in the

schools to make them aware of the needs they see among the children in their own schools.

Donations of cash and new, unwrapped toys each year also enable the members of the committee, known as Santa's Angels, to help make sure every child has a present to open on Christmas morning.

"Four-legged children are not left out of the proceeds from the event," says Hinson. The group began collecting pet food and supplies to help the local humane societies several years ago.

Donations and proceeds from the sale of t-shirts are the primary source of funds. "We've been able to help provide children with a variety of things like hearing aids and eyeglasses over the years," says Hinson, adding that the crew has also reached out to children impacted by disasters like hurricanes and burnouts.

Committee membership has grown over the years. "The crew started out with three and we're now about twenty strong," says Hinson. At the helm and in the crew's nest are Susie Watson and Captain Poo McLauchlin, two of the founding members. Watson is the harbormistress at Harboursgate Marina, and McLauchlin is a local legend who made a career



out of being a Coast Guard certified captain after serving in the Air Force. Some might remember him as the organizer of the Arthur Smith King Mackerel Tournament in the late 70s/early 80s. "Earlier this year, he was honored when the Intracoastal Waterway Little River Swing Bridge was named the Captain Archie Neil 'Poo' McLauchlin Swing Bridge," says Hinson.

The Intracoastal Christmas Regatta is a sight to see. Decorated boats in a variety of sizes launch from the Little River Inlet and travel down the Intracoastal Waterway

to Dock Holidays Marina. The parade begins at dusk and may be viewed at any point along the waterway between Little River and Dock Holidays in North Myrtle Beach.

"Don't forget to bring a new, unwrapped toy with you when you come," says Hinson, adding that toy collection boxes are also in various locations in Little River and in North Myrtle Beach. ## How to become a trustee of Horry Electric Cooperative, Inc.

### I. QUALIFICATIONS:

Below are the qualifications that must be met before a person can be elected to the Cooperative's Board of Trustees:

A. Must be a member in good standing with the Cooperative and receive electrical service from the Cooperative at his or her primary abode.

B. Must reside in the Trustee District from which Trustee is to be elected.

C. Shall not be a close relative of an incumbent board member, or of an existing employee of the Cooperative, or is employed by the Cooperative, or was employed by the Cooperative at any time during the preceding five (5) years.

D. Must not be employed by or financially interested in a competing enterprise, or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures, supplies or wiring to, among others, the members of the Cooperative.

### II. NOMINATIONS:

Below are the two methods that may be used to become nominated for the purpose of being elected as a member of the Cooperative's Board of Trustees.

A. A member may be nominated by the appointed Nominating Committee of the Cooperative as a candidate for the Board of Trustees from the Trustee District

in which the member lives and for that District's seat. The Nominating Committee will meet in January prior to the Annual Meeting held in May. For the exact date of the Nominating Committee meeting, call the office at (843) 369-2211.

B. A member can also be nominated by petition as a candidate for the Board of Trustees from the Trustee District in which the member lives and for that District's seat. Official forms must be obtained from the Cooperative and must be

signed by any twenty-five or more active members/owners in order to be considered valid. The deadline for petition candidates is sixty days prior to the date of the Annual Meeting of Members.

### III. ELECTION:

The following is how the election will take place at the Annual Meeting:

All members who have been nominated by the Nominating Committee or who have been nominated by petition will have their names appear on the official

ballot of the Cooperative. The members who are in attendance at the Annual Meeting will then select their representative to the Board of Trustees by secret ballot. If a member has been properly nominated and has no opposition, that member may be voted to the Board of Trustees by acclamation. 🗳️
