New for 2014

Be sure to bring your Official Notice Registration Card, plus your photo ID to qualify for **Speedy Pass registration**.

The card mailed to you has a special bar code on it that is unique to your membership. The bar code can be quickly scanned, and you can be registered in a matter of seconds.

There will be two Speedy Pass registration lines at each of the locations designated for registration and voting. Members who do not qualify for Speedy Pass registration will be directed to a table where employees responsible for registering members have the ability to physically look accounts up in the system. This process takes extra time, and the wait time for registration in these lines will be longer.

We need you to be there

The Annual Meeting is important. It's one of the best examples of how your membership matters. For us, it's an opportunity to report our status, share our progress and announce future plans. We also get to meet members face to face rather than through voice, electronic or written communications. For you, it's an opportunity to proactively participate in the business meeting of your electric cooperative.

Horry Electric's bylaws require a quorum—equal to 5 percent of the membership—in order to conduct an official business meeting. With a preliminary estimate of 56,597 members of Horry Electric on Annual Meeting Day, that means we'll need to have a minimum of 2,830 members register.

If we fail to meet that number, then we won't be able to do business.

Don't forget

Each member who registers, in person, at the meeting during the designated hours for Registration, will not only qualify to get the Registration Gift, but will also be automatically entered into the prize drawing.

Registration at the Annual Meeting begins at 12 noon and each Cooperative member is urged to be present and take part in the meeting.







WIRE acts fast to aid displaced elderly citizens

In 28 whirlwind minutes, 18 volunteers from electric cooperatives across South Carolina packed a trailer load of Co-op Closet bags filled with emergency supplies for displaced elderly citizens.

Crammed full of toiletries, towels, pillows, Bibles and more, the bags will be distributed to the elderly when group or nursing homes are ordered closed for safety or health violations. The volunteers are members of WIRE (Women Involved in Rural Electrification), a community outreach association affiliated with electric co-ops around the state. They gathered March 13 at The Electric Cooperatives of South Carolina, Inc.

(ECSC) in Cayce to make short work of this huge act of kindness.

It was the third Co-op Closet project undertaken by WIRE and ECSC, a service association for Palmetto State co-ops.

The similar project was done last winter, in response to a request from S.C. Lieutenant Governor Glenn F. McConnell and the state Office on Aging. The lieutenant governor reached out to the co-ops after the Office on Aging determined that elderly citizens too often are forgotten—almost left destitute—when homes are closed. The emergency relocation bags will be kept at the Office on Aging, which determines who needs assistance around the state. WIRE members sometimes help distribute the bags and, project coordinator Peggy Dantzler of ECSC notes, "To the elderly home residents, the supplies come just when they need an act of compassion."

As the lieutenant governor has said, "The 'Co-op Closet' . . . gives hope to many South Carolinians—some of whom may have lived next door or down the street from you or me." ③
